This is in continuation of this Ministry's letter referred above and your letter under reference, wherein you have requested for extension of extension of validity of aforesaid environmental clearance (EC) letter for another term.

2. The proposal referred above was placed before the Reconstituted Expert Appraisal Committee (Industry) in its 32nd meeting held during 20th -21st January, 2015. The Committee recommended for the extension of validity of EC by a period of five years with effect from 22.04.2015.

3. No effluent shall be discharged outside the plant premises and 'Zero' effluent discharge condition shall be implemented.

4. Company shall install continuous monitoring system (24 x 7 monitoring devices) for flow measurement and relevant pollutants in the treatment system and gaseous emission. The data to be made available to the respective SPCB and in the Company's website.

5. The Ministry accepts the recommendation of the REAC (Industry) and extends the validity of the Environmental Clearance letter no. J-11011/664/2008-IA II (I) dated 22nd April, 2010 for a period of five years with effect from 22.04.2015.
